**City of Hickory Ordinance: Sec. 24-1(b). – “Peddler” defined.** (...any individual...resident of the city, or not traveling by foot, motor vehicle, or any other type of conveyances, from place to place, from house to house, or from street to street, carrying, conveying or transporting any goods, wares, or merchandise of any kind, offering and exposing them for sale, or making sales and delivering articles to purchasers, or who without traveling from place to place, sells the same for sale from a wagon, motor vehicle, or other vehicle or conveyance...)

- ❖ Please attach a copy of a valid state driver's license, NC Id card, passport or military id.
- ❖ If Applicant is an employer or principal, a separate application shall be submitted for each person who will be peddling or soliciting, a separate permit will be issued for each.
- ❖ The Chief of Police or his/her designee will approve or reject the application within (15) days of the date of the application
- ❖ The Application may be rejected for the following reasons: Section 24-8 (C)
  1. The application is incomplete;
  2. The application fee has not been paid;
  3. The application contains false or misleading statements;
  4. The applicant has committed prior ordinance violations pertaining to solicitors and peddler;
  5. The applicant has been convicted of a misdemeanor involving larceny, fraud, forgery, sale of counterfeit goods and/or breaking and entering;
  6. The applicant has been convicted of felony; and
  7. Any other reasonable evidence that the applicant would pose a substantial threat to the public health, safety, morals and general welfare.
